**Number of securities that are object of the Offer:**

The object of the public offering is the purchase of a package of up to 19.625.000 **shares** issued by EVERGENT INVESTMENTS S.A., that are not in possession of the Tenderer, representing 2,0405% of the total share capital of the Issuer, with the purpose of reducing share capital through the annulment of shares.

The purchase of shares by the Tenderer in the Public Offer is part of the buyback program approved by Resolution no. 2 of the extraordinary General Meeting of shareholders on 28th April 2022, published in the Official Journal of Romania, Part IV, no. 2132 on 20.05.2022, with the purpose of reducing the share capital through share annulment. .

**Offer Price:**

The offer price is 1,41 lei/share ("Offer Price"), less trading commissions and commissions corresponding share payment.

The Offer Price was set abiding by Law no. 24/2017 on the issuers of financial instruments and market operations, and FSA Regulation no. 5/2018 on the issuers of financial instruments and market operations with its later amendments and additions.
