Please find attached the EVERGENT Investments Assets and Liabilities Statement as of May 2023, in compliance with FSA Regulation 9/2014 and 7/2020 - Annex 10 - along with a brief analysis of the main variations registered in the value and structure of the assets under management.

Main monthly evolutions by asset categories (in RON):

- listed shares: 1.2 million
- AIF listed shares: 2.2 million
- corporate bonds: + 0.2 million
- fund units: + 6.6 million
- monetary instruments: + 18.6 million

The main asset classes in the total value of the assets under management: listed shares including the AIF listed shares 72.7%, unlisted shares 11.0%, fund units 10.3%, monetary instruments 3.1%.

The net result, in the amount of RON 33.37 million, consists of RON 24.33 million net profit and RON 9.04 million net gain on the sale of assets reflected in the retained earnings - accounting treatment in accordance with IFRS 9.

Furthermore, we inform you that in accordance with FSA Authorization no. 74 of 18 May 2023, the new depository of EVERGENT Investments' assets is Banca Comerciala Romana. The net asset value for May 2023 is the first certified statement by BCR.
