Please find attached the EVERGENT Investments Assets and Liabilities Statement as of February 2024, in compliance with FSA Regulation 9/2014 and 7/2020 - Annex 10 - along with a brief analysis of the main variations registered in the value and structure of the assets under management.

Main monthly evolutions by asset categories (in RON):

- listed shares: + 50.4 million
- AIF listed shares: - 0.5 million
- unlisted shares: + 9.4 million
- corporate bonds: + 0.1 million
- fund units: + 1.8 million
- monetary instruments: + 15.8 million

The main asset classes in the total value of the assets under management: listed shares including the AIF listed shares 69.9%, unlisted shares 8.9%, fund units 8.8%, monetary instruments 10.7%.

The net result, in the amount of RON 23.86 million, consists of RON 0.58 million loss and RON 24.44 million net gain on the sale of assets reflected in the retained earnings - accounting treatment in accordance with IFRS 9.
