Please find attached the EVERGENT Investments Assets and Liabilities Statement as of April 2025, in compliance with FSA Regulation 9/2014 and 7/2020 - Annex 10 - along with a brief analysis of the main variations registered in the value and structure of the assets under management.

Main monthly evolutions by asset categories (in RON):

- listed shares: - 44.0 million
- AIF listed shares: + 0.7 million
- unlisted shares: - 5.9 million
- fund units: - 1.8 million
- monetary instruments: - 25.5 million

The main asset classes in the total value of the assets under management: listed shares including the AIF listed shares 70.5%, unlisted shares 10.0%, fund units 9.4%, monetary instruments 8.9%.

The net result, amounting to RON 5.40 million, consists of a loss of RON 11.89 million recognized in the profit or loss account and a net gain of RON 17.29 million on the sale of financial assets, reflected in retained earnings - in accordance with the accounting treatment under IFRS 9.
