Please find attached the EVERGENT Investments Assets and Liabilities Statement as of July 2025, in compliance with FSA Regulation 9/2014 and 7/2020 - Annex 10 - along with a brief analysis of the main variations registered in the value and structure of the assets under management.

Main monthly relevant evolutions by asset categories (in RON):

- listed shares: + 63.8 million
- AIF listed shares: + 2.8 million
- unlisted shares: - 1.9 million
- fund units: + 11.9 million
- monetary instruments: + 1.1 million

The main asset classes in the total value of the assets under management: listed shares including the AIF listed shares 68.8%, unlisted shares 9.3%, fund units 9.6%, monetary instruments 11.0%.

The net result, amounting to RON 233.45 million, consists of RON 122.67 million net profit and RON 110.78 million net gain on the sale of financial assets reflected in retained earnings - accounting treatment in accordance with IFRS 9.
