Main monthly relevant evolutions by asset categories (in RON):

- listed shares: + 85.4 million
- AIF listed shares: - 1.3 million
- corporate bonds: + 0.2 million
- fund units: + 18.4 million
- monetary instruments: - 40.8 million

The main asset classes in the total value of the assets under management: listed shares including the AIF listed shares 70.7%, unlisted shares 8.7%, fund units 10.7%, monetary instruments 8.3%.

The net result, amounting to RON 296.97 million, consists of RON 177.81 million net profit and RON 119.16 million net gain on the sale of financial assets reflected in retained earnings - accounting treatment in accordance with IFRS 9.
